**MEMORANDUM OF UNDERSTANDING (MoU)**

**Shree Agrasen Mahavidyalaya, Dalkhola, Uttar Dinajpur**

*This Memorandum of Understanding (MoU) is made on 26<sup>th</sup> November, 2024 between Harishchandrapur College and Shree Agrasen Mahavidyalaya for mutual cooperation witnesseth in academic exchanges, programme development and research. This document establishes the guiding terms and principles of collaboration between the two organizations:*

**I. Legal Frameworks of Both the Organizations**

**Harishchandrapur College**, established in 2008, having its campus located at Pipla, Harishchandrapur, Dist. - Malda, West Bengal 732125, affiliated with University of Gour Banga, is one of the premier institutes of higher learning under the Department of Higher Education, Government of West Bengal aided college, represented by its Principal Prof. (Dr.) Sumit Nandi hereinafter referred to as the FIRST PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns).

**AND**

Shree Agrasen Mahavidyalaya, represented by its Principal Prof. (Dr.) Jayeeta Basu hereinafter referred to as the SECOND PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns), located at an ideal site within the Municipal area surrounded by picturesque landscape with ever green, calm and quite atmosphere free from pollution, din and bustle of Municipal crowd, is the sixth degree college in the district of present Uttar Dinajpur (then West Dinajpur). It was initially affiliated to the University of North Bengal. Subsequently it comes under the jurisdiction of the University of Gour Banga. So it is now affiliated to the University of Gour Banga. Meanwhile, it has come into limelight for its brilliant performance and excellent result of the students in the university examinations comparable with many



other star colleges of the University. Within a very short span of time, it has exceptionally attained the significant growth and excellence in the field of higher education. The Mahavidyalaya was honored by the International Business Council, New Delhi with National Udyog Excellence Award in 2004.

## **II. Purpose of the Agreement**

Both the Parties are pleased to enter upon an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions through following but not limited to:

1. Joint teaching and research projects.
2. Collaboration in the area of academic publications, research activities, field trips etc.
3. Visit and exchange of faculty and students also training for upgradation of staff.
4. Joint educational/vocational courses.
5. Joint consultancy, PhD. supervision, scientific publications.
6. Co-hosting and participation in conferences, seminars, symposiums and workshops.
7. Joint organization of social and cultural programs for commemoration/celebration.

The scope of this MoU is not restricted or limited to the list of items specifically mentioned above. Further areas of collaboration can be expanded in the future according to needs, as they arise, as the above list is not exhaustive.

## **III. Execution of the Agreement**

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, period the sub-agreement will be in effect, and administrative responsibility within each institution subject to specific programmes jointly organized and executed

## **IV. Term and Expiration of the Agreement**

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of five years. After these five years it will be automatically extended for same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the Parties.



Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

#### **V. NON-EXCLUSIVITY:**

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

#### **VI. SPECIAL PROVISIONS**

1. Each party will take approval from the other party in writing prior to using the latter's name and logo for the activities hereunder on a case-by-case basis.
2. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
4. Neither party can misuse this MoU by involving the name of the other without the written consent from the other party.
5. There will be no financial involvement by either of the parties.

#### **VII. FUNDING**

- a. Expenses for maintaining infrastructure shall be borne by the respective institutions. The transportation and personal expenses of exchanging students, teachers, or officers shall be covered by the requesting individuals/Institutions.
- b. Financial expenses for internships of professors and researchers, which will be arranged at the parties' request, as well as travel expenses, shall be covered by the requesting institution/s. No fees will be paid to the professors/researchers as they remain in their positions at their home institution, which will continue to pay their salaries.

#### **VIII. DISPUTES**

If any dispute arises in respect of the MoU, both the organizations will discuss and settle the matter amicably.
