## **PREAMBLE:**

The National Education Policy 2020 (NEP) has been formulated in India. It seeks to explore the full human potential and develop well-rounded, competent individuals through offering the right environment. It looks to enable access to inclusive and equitable quality education. NEP 2020 framework keeps the provision for lifelong learning, enlightenment to newer areas of knowledge, generating skills to meet industrial demands and sustained economic development. It encourages multidisciplinary studies to develop a comprehensive view of issues from a realistic paradigm, holistic approach to education, cultural ethos and moral values. It seeks to cultivate a scientific temperament and problem-solving attitude.

At this backdrop, a Memorandum of Understanding with Kaliaganj College and Shree Agrasen Mahavidyalaya will be beneficial for the students of both the colleges,





## 1. Objectives

- 1.1 The objective of this MoU for the formation and functioning of the Academic Cluster is to express the willingness of the above colleges to engage in an effort to promote academic atmosphere and activities in their respective departments and courses. Various departments of the above colleges will enhance the quality in the field of teaching and research by sharing and exchanging faculties and students.
- 1.2 Specific academic activities under this MoU will be identified through consultation among faculty members of specific departments of the stipulated colleges.
- 1.3 Each college agrees to provide their academic and technical assistance to carry out specific activities, which will include hosting conferences/workshops/symposiums, implementing skill-based training programs, undertaking extension activities, starting new add-on courses and developing research atmosphere in the respective departments.

## 2. General Terms of MoU

- 2.1 **Duration of MoU:** This MoU will be effective from the date of agreement and will have an initial duration of four years. There is also a provision to extend the MoU.
- 2.2 **Coordination:** In order to carry out and fulfil the aims of this agreement, both colleges will empower an appropriate faculty to coordinate the implementation of activities. The concerned faculties will meet regularly to discuss about plan, implementation and progression of the activities.





**2.3 Termination of MOU:** The partnership covered by this MoU shall be terminated upon the completion of the agreed period of four years. The agreement may also be terminated by giving a notice with a written form from both sides

**2.4 Extension of Agreement:** The MoU may be extended according to the willingness of the MoU signing colleges with prior intimation and permission of the authorities, one month before the end of the MoU.

**2.5 Programme Consult:** All programmes will be taken up by the concerned department of the college with prior consultation with the corresponding department of the other college.

**2.6 Venue of the Programme:** Each college will organize any programme on their own premises by using their own assistance and resources. A third place may be treated as a venue of any programme but that must be done after a discussion and consultation of the two colleges with the financial sharing.

### 3. Other Provisions

**3.1** Initially, the Department / Faculties of the MoU signing colleges will facilitate exchange programme, hosting conference/workshop/symposium /inter-college student debate, introducing add-on courses/training programs on Communicative English, Performance Studies, Content Writing and Digital Archival. MoU-signing colleges make initiatives regarding Social





Services, Environmental Action and Local Community Development Programmes.

- 3.2 Students and teachers may visit and use archives, the departmental library, laboratories as well as central library of the MoU-signing colleges as and when required.
- 3.3 Class teaching may be shared to the students (only to those who have proper ID card) with prior permission of the authorities along with proper Identity Card.
- 3.4 Faculty exchange for special lectures, seminar classes, workshops, and professional and skill-based training programs will be made at the departmental level in consultation with the respective faculties and the departments concerned. Proposals for introducing new professional courses, certificate courses and short-term training programs will be given special importance from all the departments.
- 3.5 All parties assume that this agreement does not go against the rules and regulations of the Government of WB & UGC.
