#### INTRODUCTION

Gender Audit of an educational institutions is a process for organisational assessment and a tool for action planning from a gender perspective. It critically examines the capacity of institutions to ensure a 'safe and secure' ambience for women and girl students, faculty and administrative staff. The participatory audit process helps to identify institutional strengths and challenges to integrating gender, as well as gender equity, in the institution's systems and operations and in programmes and activities. Gender audit encourages the stakeholders in an educational institution to engage in a dialogue and reflect about the strengths and gaps of the system vis-à-vis gender related issues. Shree Agrasen Mahavidyalaya as an institution is committed to equity and equality of opportunity. It also aims to offer quality education to all students irrespective of disparities in background. To fulfill this aim, the College decided to go for a Gender Audit. Shree Agrasen Mahavidyalaya with the initiative of the Women Development Cell and Internal Quality Assurance Cell (IQAC) have compiled this Gender Audit.

#### **ABOUT THE COLLEGE**

With the missionary ideals in heart, thirst for knowledge in mind, untiring efforts, noble sacrifices, unmixed stewardship and bold initiative of the local people of Dalkhola in general, an attempt was made by them for establishment of a college in the locality. Consequently, Shree Agrasen Mahavidyalaya was brought into existence as a center for higher education on the auspicious day of 1st September, 1995 to fulfill the increasing desire and demand for higher studies in the locality after a long period of 48 years of our Independence. Shree Agrasen Mahavidyalaya was the perfect one of which right choice of location was made for providing encouragement and patronage to the poor and backward students. It is located at Bhusamoni at a distance of 2.5 km. from the nearest railway station of Dalkhola and 500 meters away from National Highway 34 (N.H.- 34) possessing a good campus comprising 3.88 acres of land enriched with the potentiality for developing it further into an ideal, modern and progressive institution for higher education. Shree Agrasen Mahavidyalaya located at an ideal site within the Municipal area surrounded by picturesque landscape with ever green, calm and quite atmosphere free from pollution, dins and bustles of Municipal crowd, is the sixth degree college in the district of present Uttar Dinajpur (then West Dinajpur). It was initially affiliated to the University of North Bengal. Subsequently it comes under the jurisdiction of the University of Gour Banga. So, it is now affiliated to the University of Gour Banga. Meanwhile, it has come into limelight for its brilliant performance and excellent result of the students in the university examinations comparable with many other star colleges of the University. At present under NEP 2020 16 Major courses are offered to the students from which they can opt any one Major course for pursuing 3 years / 4 years B.A./ B.Sc./ B.Com. (Hons. / Hons with Research) degree program. The teaching learning process is enriched and made productive by rich experience of teachers and availability of up-to-date resources to students. Apart from academics, the students are always encouraged to nurture their hidden talents through various extra-curricular activities. For the holistic development of the youth of today, we also encourage conservation of biodiversity through its sustainable development to save our Mother Nature. As our objective is advancement of learning accompanied by modern teaching aids, the campus is now Wi Fi enabled with digital classrooms. Also, the library resources are enormous with a huge collection of books and journals. The institution has zero tolerance for ragging and the role of the Anti-ragging cell as well as the administration and the Students' Council, ensures that the campus is free from any discriminatory practices. The Women Development Cell, Grievance Redressal Cell function in unison to create a free and fair environment for holistic development of the students.

# **OBJECTIVES OF GENDER AUDIT**

- To find out the areas where gender imbalance exists and the factors behind the gender imbalance.
- To establish good gender balance in decision-making processes in all areas of the college activities.
- Make recommendations for overcoming the gender gap.
- To promote gender equality within the campus community.
- To observe the college's efforts and competence to prevent sexual harassment.

## Methodology

Although there is no standard approach for carrying out a gender audit. In our college, as part of the Audit, survey method has been used by using questionnaire through Google form. To collect primary data on Gender related aspects, questionnaire is designed for the girl students of the college. The total sample size of the study is 171 number of girl students. The questions in the study have been given with a three-point rating scale as agree, disagree and neutral. The following gender sensitive indicators have been used to evaluate:

- a. Organization and management
- b. Infrastructure
- c. Students' participation and involvement
- d. Existence of women cell and Grievance Redressal Cell

- There is a separate common room for girl students with a sanitary pad vending machine.

- Organize regular gender sensitization programmes, cultural programmes, competitions among students to raise awareness.




#### GENDER BALANCE WITHIN THE INSTITUTION




#### STUDENTS' SCHOLARSHIPS 2023-24

The college plays an active role in facilitating students to get various scholarship schemes and grants provided by the Government. Under the Prohibition of Child Marriage Act 2006 (PCMA), Govt of West Bengal has introduced the **Kanyashree Prakalpa** which bagged an UN award in 2018, seeks to improve the status and wellbeing of girls, specifically those from socio-economically disadvantaged families through Conditional Cash Transfer. 

#### NAME OF THE SCHOLARSHIP: OASIS




Among the 847 students who applied for the OASIS Scholarship, 260 were male candidates and 587 were female.

Among the 758 students availing AKYASHREE; 309 are male and 449 are female students.


#### NAME OF THE SCHOLARSHIP: CHIEF MINISTER RELIEF FUND


Among the 192 students availing SVMCMS Scholarship; 79 are male and 113 are female students.

#### NATIONAL CADET CORPS

NCC is the biggest youth organization of the country with more than 15 lakh cadet strength. It was established in the year 1949 in its present form, though it follows the legacy of the University Cadet Corps established in 1917. NCC as an organization is contributing towards the development of the youth in the country. It is opened to educate boys and girls of schools and colleges of the country. It is administered by the Ministry of Defence, Government of India. The motto of NCC is "Unity & Discipline". Training activities in NCC consists of basic training of the regular armed forces is provided throughout the academic year.

NCC offers a specialised course which includes the practical training of weapon handling, firing, military tactics, civil defence, first aid, map reading and many more. This course consists of 3 years of senior division cadets followed by certificate examinations. The 'C' certificate earned by an NCC cadet will enable him or her to join the Armed Forces in different categories according to their capabilities.




# The National Service Scheme (NSS)

Among the total 33 Teaching staff, 11 are Female and 22 are Male.












The environment inside the campus is safe for girl students'-( ছাত্রীদের জন্য ক্যাম্পাসের পরিবেশ নিরাপদ)







- A Meditation Centre will be established to deal with the everyday stress and anxieties of the females.
- For a healthy and fit life, yoga camps and aerobics classes will also be organized by the Cell.
- To spread the awareness of women empowerment and gender equality various seminars, workshops and events will be organized.
- To start with short term certificate courses like Dress Designing & Tailoring and also Beautician Course.

#### **OBSERVATION**

- It will be nice if the Institution can show that there are courses on gender as part of the syllabus.
- If there are any specific budgetary provisions for girl students besides scholarship.
